- D. Monitor bins containers, compost piles, burning pit, and other areas.
- E. Prepare written invoices for materials that require disposal fees; collect fee if paid on-site.
- F. Report violators of the Town of Lodi Solid Waste Ordinances regarding site policies and disposal requirements to Public Works Director.
- G. Enforce use of the Transfer Site by Town of Lodi residents only.
- H. Assist in the day-to-day duties of the Transfer Site and various other duties as required or as assigned by the Public Works Director.
