

## ORDINANCE NO. 2022-04

### AN ORDINANCE TO REPEAL AND RECREATE THE APPOINTMENT OF ALTERNATE BOARD OF REVIEW MEMBERS

The Town Board of the Town of Lodi, Columbia County, Wisconsin does hereby ordain as follows:

1. Section 2.45 of the Lodi Municipal Code is hereby repealed and recreated to read as follows:

#### **SECTION 2.45**      **BOARD OF REVIEW**

(a) **Creation.**

The Board of Review is hereby created for the Town.

(b) **Composition.**

The board shall consist of five members, all of whom shall be residents of the Town.

(c) **Appointment and term.**

The members shall be appointed by the Town Chairperson with the approval of the Town Board. They shall hold office for one-year terms or until their successors are appointed. In case of vacancies, appointments shall be made for the unexpired term. Appointments shall be made by the first Monday in May, or as soon thereafter as is practicable. In addition, up to four alternate members may be appointed by the Town Chairperson and confirmed by the Town Board. The alternate members shall act only when a regular member is absent or refuses to vote because of a conflict of interest in the matter. The terms for the alternates shall be one-year terms.

(d) **Compensation.**

The members of the Board of Review shall receive no compensation for their services.

(e) **Confidentiality of income and expense information.**

Whenever the assessor, in the performance of his duties, requests or obtains income and expense information pursuant to Wis. Stats. § 70.47(7)(af), then such income and expense information that is provided to the assessor shall be held by the assessor on a confidential basis, except, however, that said information may be revealed to and used by persons in the discharge of duties imposed by law, in the discharge of duties imposed by office (including, but not limited to, use by the assessor in performance of official duties of the assessor's office and use by the Board of Review in performance of its official

duties), or pursuant to order of a court. Income and expense information provided to the assessor under Wis. Stats. § 70.47(7)(af), is not subject to the right of inspection and copying under Wis. Stats. § 19.35(1), unless a court determines that it is inaccurate.


(f) **Hearing procedure.**


Board of Review proceedings and appeals shall be as governed by Wis. Stats. chs. 70 and 74, including without limitation by enumeration herein, Wis. Stats. § 70.47 as from time to time amended.


The above and foregoing Ordinance was duly adopted at a regular meeting of the Town Board of the Town of Lodi held on the 15 day of August, 2022.


